The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

**Basic Services of Funeral Director and Staff \$1,895.00**

Our fee for the basic services of funeral director and staff includes, but is not limited to: staff to respond to initial request for service 24 hours/7 days per week; arrangement conference with family and responsible parties; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notice; and coordination with those providing other portions of the funeral, e.g., cemetery, crematory, vault companies and others as required. Also included in this charge are overhead expenses relative to our facilities such as professional licensing, legal and accounting fees, insurance, building and utility expenses, parking lot and grounds maintenance, taxes, equipment, furnishings, inventory costs, recordkeeping, secretarial, administrative expenses and governmental/OSHA compliance. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains).

**Embalming and Preparation of the Remains \$ 875.00**

Embalming.....\$ 600.00 (\*)

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a service with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or direct burial.

Preparation of the remains (with embalming) .....\$ 275.00

Cosmetics, dressing, casketing, and hairdressing as needed & completed after embalming.

Preparation of the remains (no embalming) .....\$ 225.00

Our services include set up of viewing/visitation area, placement of remains, necessary equipment, display of floral arrangements, supervision and attendance during visitation which is limited to one day—afternoon and evening only.

Use of facilities and staff for funeral, rites or ceremony..... \$ 450.00

At the funeral home—our service includes coordinating the funeral arrangements, supervision of funeral & staff to attend the funeral, rites or ceremony.

At the church—our service includes coordinating the funeral arrangements, supervision of funeral, staff, and necessary equipment to attend the funeral, rites or ceremony.

**(B) RECEIVING REMAINS FROM ANOTHER FUNERAL HOME (Ship-in) \$ 2,345.00**

This charge includes necessary services of funeral director and staff, arrangement conference, temporary shelter of remains, a proportionate share of overhead expense, transportation of remains to funeral home and to the cemetery or crematory (no family present). This charge does not include the use of facilities, viewing/visitation, rites or ceremonies prior to the final disposition. (NO visitation—NO services). When the remains are delivered to our funeral home and we have no transfer/removal from the airport, the charge for receiving remains from another funeral home is \$1895.00.

For a graveside/committal service, with family, add + \$325.00 = \$2,670.00 (H).

NOTE: For a ship-in service desiring viewing/visitation, rites or ceremony prior to direct disposition, see (A) or (K)

**(C) FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME (Ship-out) \$2,345.00**

This charge includes necessary services of funeral director and staff, arrangement conference, temporary shelter of remains, a proportionate share of overhead expense, transfer/removal of remains, embalming, minimum shipping receptacle for body, necessary authorizations, legal documents and local transportation to airport. This charge does not include the use of facilities, viewing/visitation, rites or ceremonies prior to the forwarding of remains.

(NO visitation—NO services). When the remains are picked up at our funeral home we have no trip to airport and no shipping receptacle, the charge for forwarding of remains to another funeral home is \$1160.00 (removal & embalming)

**(D) DIRECT CREMATION (Up to 250 lbs.) Complete Package Direct Service from \$ 2,280.00**

This charge includes the transfer/removal of remains, use of refrigeration facilities, shelter of remains, necessary services of funeral director and staff, arrangement conference and completion and filing of authorizations & legal documents, a proportionate share of overhead expenses and transportation to crematory (no family present). This charge does not include embalming or the use of facilities, viewing/visitation, rites or ceremonies prior to the direct cremation. (NO visitation—NO ceremonies). A casket is not required. An alternative container is included. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The alternative container, included in this package, is composed of rigid cardboard and/or wood and does have an outside covering. Local crematories and Missouri law do require the use of a rigid, leak resistant container to encase the remains.

This private identification is limited to 12 designated/qualified persons with appropriate preparation of the remains by funeral home for identification only. No rites or ceremonies are included. Each designated/qualified person will sign the hold harmless/authorization for viewing agreement.

**(G) DIRECT BURIAL SERVICES (also, see "J") from \$ 2,280.00**

This charge includes the transfer/removal of remains, use of refrigeration facilities, shelter of remains, necessary services of funeral director and staff, arrangement conference, and completion and filing of authorizations and legal documents, (for dressing of an un-embalmed remains add \$150.00), a proportionate share of overhead expenses and transportation to cemetery (no family present). (OBC purpose: 1) keeps the weight of the earth filling the grave off the casket, about 2000# average; 2) OBC reduces grave maintenance; 3) vaults keep outside elements out of the casket.)

In most areas of the country, state or local law does not require that you buy an outer burial container to surround the casket in the grave. However, many cemeteries require that you have such a container so that the grave will not sink in. Either a concrete box grave liner or concrete vault will satisfy these requirements.

(The following are at the actual cost of the vault company.)

Saturday Overtime Vault Company Charge (for concrete box or vault on Saturday) \$ 75.00  
(Sunday & Holiday Charges...\$175.00) Lowering device only \$ 70.00

The vault company provides the following when the cemetery does not provide:  
Tent, chairs and lowering device: With concrete vault \$ 125.00  
Tent, chairs and lowering device: With concrete box \$ 175.00  
Tent, chairs and lowering device: With no outer container \$ 350.00

(\* Vaults are so constructed as to keep “outside elements” out of the vault when closed.)

Candles/incense: Open flame candles and/or incense are allowed in the funeral home ONLY if a \$500 cash deposit is made prior to the gathering. In the event no damage occurs, the deposit will be applied towards the funeral balance, or if the funeral is paid in full, it is returned to the family. If damages occur, the funeral home will repair the damages and any differences will either be billed to the family or returned to the family. The only candles allowed with no deposit are enclosed or jar candles and must be approved by the funeral director before being lit.
